Madam, it is a foundational legal principle that **“Justice Delayed is Justice Denied”**. My clients – in the cases identified – have been done a grave injustice by the Court and my many efforts to bring some resolution to this vexing issue is met with proven futility.

Additionally, I am of the firm view that this injustice meted out to my clients is aggravated by the fact that the Court – on November 3<sup>rd</sup>, 2023 – has brought an illegal and unlawful Contempt Order against me, and this is what is impacting my clients. In fact, many of them have reported to me that having called the Court to inquire about delivery of judgment or a hearing date for their cases, they are being told *“your representative is responsible for the delay”*. Further, having regard to my experience with the Court over the last few years and continuing, there is every reason to form the view that this is intended to be my punishment for not having accepted to obey and comply with an unlawful and illegal Order.

In conclusion, I am again writing about these matters and await your response before proceeding with whatever lawful action is available to my clients.
